Where to file

State

Wisconsin registration: No. Routine kitchen inspection: No. Home-canned goods must be sold at community or social events or farmers' markets in Wisconsin (§97.29(2)(b)2.b). The Kivirist court order applies to direct-to-consumer sales by home bakers. Products cannot be sold to retail food establishments or distributed through wholesale channels without a license.

Zoning / home occupation

Varies. No permit required for Kivirist-qualifying home bakers or Pickle Bill sellers. Wood County may have local zoning home occupation requirements. No Wood County-specific cottage food ordinance found.

Health

No. DATCP may investigate upon complaint. Kivirist order restricts DATCP enforcement against qualifying home bakers.

Business license

Varies

Pickup / delivery

Pickle Bill: sales at community events or farmers markets only, \$5,000/year cap. Kivirist bakers: direct to consumer, low volume, from home — no stated dollar cap. No internet/mail order for unlicensed bakers.

If you rent a commissary kitchen

DATCP licenses food processing; local health licenses restaurants. Wisconsin unlicensed home baking is a narrow path. A commissary is typically a DATCP food processing plant or a local food-service license. Ask the kitchen which license they hold.
